Technologies

1. SIP beta is open for external registrations

SIP (Social Investment Platform) beta is now open for external registrations! Welcome to register on our site (<http://iob.community>) and share your feedback with us.

2. PoET™ (Proof of Enquiries and Trades)

Designing market transparency protocol to enable the order books on the blockchain, which will expose unfilled orders and prevent market manipulations. PoET protocol is being developed by IOB Mesh Technology GmbH (IOB Cologne). IOB Cologne works closely with our third-party blockchain partners and IOB North American trading teams to implement the PoET protocol on our Smart Trading™ System.

1. Engagement of Institutional Investors

We are at the final stage of due diligence with the major institutional investor. Continuing investment negotiations with industry leaders regarding IOB and its portfolio companies.

2. Smart Trading™ - Tier 1 Market Maker Accounts with Exchanges

IOB has successfully opened the account at Huobi as Tier 1 market maker. IOB has tested the available API and is working with the trading department team on solutions to improve their trading platform.

3. Re-Engagement of Wall Street

In anticipation of institutions entering the blockchain space IOB is in the process of opening an IOB Wall Street office and cooperating with old Wall Street colleagues and friends;

4. Financial Audit

IOB is undergoing a financial audit with Pharos Advisors for the SEC filing.

Conferences & Meetups

- Yale ReiSoleil attended StartEngine Summit held in Santa Monica on Oct 20th. This event brought together the leaders of tokenizing securities and alternative assets. Christopher Cox, a former SEC chairman, made a speech.
- Yale ReiSoleil attended Crypto Invest Summit in LA from Oct 22th to 24th. This summit focused on sustainable investing blockchain technologies. Yale met Tokenized, TokenSoft, Spice VC and some other attendees to discuss the trends in the industry and explore cooperation opportunities.

Portfolio Companies & Partnerships

IHT (i-House Token)

- IHT enters a partnership with games and apps developer Animoca Brands. Animoca is a cross-platform app publisher of entertainment products for Android smartphones and tablets which has listed on ASX.
- IHT was recently listed on Cashierest, the Top 3 cryptocurrency exchange of Korea.
- IHT partners STONetwork and Liquefy to launch STO lab, developing security token to bring revolutionary change to asset markets.
- IHT has sent the 2nd half of tokens to IOB which will be distributed to our IOB tokens later. The distribution ratio and date will be announced shortly.

Fundamental Capital

- The new Multi-Investment-Strategies-Platform (similar to Amazon for investment strategies) and the additional strategy of expansion have been well received by the community. The technical specifications and design are under final coding and ready for implementation for the first prototypes.
- The business development team has involved four institutional partners who will get on board as the first B2B clients by the end of the year.

XMED chain (XMC)

- Xmedchain launched the first public welfare activity. The recruitment of patients has officially launched on October 12th.

- The beta version of the XMEDChain (XMC) English website was developed and launched successfully on October 22nd.

- Moolyacoinsale is halfway through its mark, despite the rough seas of the ICO market
 - Employing smart marketing, engaging actively with the community, forging partnerships - the team is one of the top ICO's in most listing sites.
